Re: CONSIDERATION OF THE RELEASE AND DISTRIBUTION OF FY 2010 APPROPRIATIONS FROM AMENDED SUBSTITUTE HOUSE BILL 1 OF THE 128TH GENERAL ASSEMBLY.

The Chancellor of the Ohio Board of Regents is mandated by the Ohio General Assembly to administer the distribution of various line item appropriations included in Am. Sub. H.B. 1 of the 128th General Assembly.

Pursuant to the legislation, certain of these funds are provided for specific purposes and others are to be distributed at the discretion of the Chancellor. This release is divided into the following three parts:

- Group A: The line items in this group include those over which the Chancellor has little discretion; institutions receiving these funds are identified in the budget bill.
- Group B: The line items in the second group include appropriations for operating expenses, debt service, and financial aid. These are released to the extent necessary (i.e., an unexpended balance may remain at year end).
- Group C: The line items in the final group consist of items over which the Chancellor has some control. Not all of the funds in this latter group are being released at this time.

The final appropriations for FY 2010, contained within this directive, will be reconciled with agency expenditures that occurred under the three interim budgets approved in Amended Substitute H.B. 16, Amended Substitute H.B. 245, and Amended H.B.150.

Agency staff prepared the request and posted its allocation on the Regents' web site for the purpose of providing a period of public comment before final approval by the Chancellor. No comments were received. The materials posted for comment and the request to release and distribute funds are attached to this document.

Based on my review of staff recommendations, I hereby approve the request to release and distribute the following appropriations for FY 2010 as specified in Am. Sub. H.B.1.

BACKGROUND

Consideration of partial release and distribution of FY 2010 appropriations from Amended Substitute House Bill 1

The state's biennial budget directs the Chancellor of the Ohio Board of Regents to distribute higher education funds in accordance with various requirements. In this action the Chancellor is requested to consider the release and distribution of \$2,540,588,540 in FY 2010 appropriations.

As has been the case in the past, this release is divided into three parts. The first group of items includes those over which the Chancellor has little discretion; institutions receiving these funds are identified in the budget bill. The second group of items includes those for operating expenses, debt service, and financial aid. These are released to the extent necessary (i.e., an unexpended balance may remain at year end). The third group consists of items over which the Chancellor has some control. Not all of the funds in this latter group are being released at this time.

Attachment A of this document outlines all of the funds in the third group, as well as some of the funds in the first group for which the budget bill earmarked moneys for specific institutions or entities.

The Chancellor's release of funds does not signify that institutions or other entities will receive the total amount of resources in July. In most instances, monies are disbursed from the state treasury on either a monthly or quarterly basis.

These supported programs are required to satisfy the state match and maintenance of effort requirements for this state-administered grant program.

Of the total appropriation, Am. Sub. H.B. 1 sets aside \$507,558 in FY 2010 for the support and operation of the State Literacy Resource Center Program. In addition, the appropriations act requires the Chancellor of the Board of Regents to submit a funding formula to the Controlling Board, no later than August 31, 2009, for the allocation of the remaining FY 2010 funds for ALI 235-443.

235-444 – POST-SECONDARY ADULT CAREER-TECHNICAL EDUCATION

As is done each year, the distribution of the remaining FY 2010 funds will be based on a methodology to be finalized by the Advisory Committee of Library Deans. Pursuant to §371.50.60 of Am. Sub. H.B. 1, Central State University Speed to Scale, shall be used to achieve the goals of the Speed to Scale Plan, which include increasing student enrollment through freshman recruitment and transferred students, increasing the proportion of in-state students to 80 per cent of the total student population, and increasing the student retention rates between the first and second year of college by two per cent each year. The goals shall be accomplished by targeting student retention, improved articulation agreements with two-year campuses, increased use of alternative course options, including online coursework and Ohio Learning Network resources, College Tech Prep, Post Secondary Enrollment Options, and other dual-credit programs, and strategic partnerships with research institutions to improve the quality of Central State University's offering of science, technology, engineering, mathematics, and medical instruction.
