

OHIO BOARD OF REGENTS

Agenda Item 3.19 Consideration of release and distribution of \$4,174,074 in remaining FY 2004 Family Practice appropriations and \$2,047,510 in remaining Primary Care Residency appropriations from Amended Substitute House Bill 95 of the 125th General Assembly.

RESOLUTION

WHEREAS, the Ohio Board of Regents is mandated by the Ohio General Assembly to administer the distribution of various line item appropriations included in Am. Sub. H.B. 95 of the 125th General Assembly; and

WHEREAS, certain of these funds are provided for a specific purpose and others are to be distributed at the discretion of the Board; and

WHEREAS, the Family Practice appropriation was created to support education and training of medical students and residents in family practice; and

WHEREAS, the Primary Care Residency appropriation was created to support education and training of medical students and residents in primary care; and

WHEREAS, a portion of these funds were released by the Board in June 2003 and distributed to campuses for cash flow purposes in August 2003; and

WHEREAS, the Family Practice and Primary Care appropriations are distributed in accordance to formulas that recognize the number of graduates of Ohio medical colleges who are currently physicians in family practice medicine or who have entered primary care residencies; and

WHEREAS, these formulas have been updated to reflect graduation data for the 2003 academic year.

NOW, THEREFORE,

BE IT RESOLVED: upon the recommendation of the Chancellor and with the concurrence of the Resources & System Efficiency Committee of the Ohio Board of Regents, that the remaining FY 2004 appropriations for Family Practice and Primary Care Residencies, as described in the attached tables and made a part hereof, be approved for distribution.
