## **OHIO BOARD OF REGENTS TO HOLD SPECIAL MEETING March 21 via videoconference**

**COLUMBUS, Ohio** – The Ohio Board of Regents will hold a special meeting at 10 a.m., Tuesday, March 21, 2006, via videoconference from several sites around Ohio.

The purpose of the meeting will be to consider a request by Tiffin University for approval to appropriate identified parcels of property pursuant to §3333.08 of the Revised Code and Chapter 163 of the Revised Code, eminent domain proceedings, and personnel matters.

Media and the public are encouraged to attend the meeting.
