1. Off-campus students are billed an additional \$66 per semester for the technology fee.

2. Shawnee State has a reciprocity agreement with Kentucky such that it considers residents of Mason, Lewis, Boyd, Greenup, Carter, Elliot, Lawrence, Fleming & Rowan counties in Kentucky as qualifying for Ohio resident tuition.

3. Akron offers a reduction to the out-of-state surcharge for academically qualified students.

4. Effective Fall 2008, the University of Akron redesigned a non-mandatory parking fee into a transportation fee that is charged to all full-time students. Since the transportation fee is paid by all full-time students, it appears in the Regent's annual survey as a general fee. The transportation fee, however, is not uniformly assessed to all students and therefore not subject to the legislative mandate restricting (instructional and general) fee increases at Ohio's public colleges and universities.

5. Youngstown State has a separate out-of-state "Western Pennsylvania Advantage" surcharge of \$100 for students in Allegheny, Beaver, Butler, Crawford, Erie, Lawrence, Mercer and Venango counties in Pennsylvania. Additionally, YSU offers a regional out-of-state surcharge of \$1,346 for residents of its Regional Service Area, which includes Chautauqua County in New York; Armstrong, Clarion, Fayette, Forest, Greene, Indiana, Jefferson, Warren, Washington and Westmoreland counties in Pennsylvania; and Brooke, Hancock, Marshall, and Ohio counties in West Virginia.

1. Instructional fee amounts reflect lower-division undergraduate fees. Upper-division instructional fees are \$2,817. The general/facilities fee and out-of-state surcharge is the same for both lower- and upper-division courses.

1a. Kent State has a separate out-of-state rate of \$796 per semester for students attending regional campuses and residing in select counties in western Pennsylvania and northern West Virginia. The specific counties are Allegheny, Beaver, Butler, Crawford, Erie, Lawrence and Mercer in Pennsylvania and Brooke, Hancock and Ohio in West Virginia.

2. Instructional fee amounts reflect lower-division undergraduate fees. Upper division instructional fees are \$3,309. The general/other fee and out-of-state surcharge are the same for both lower and upper division students

3. Amounts reflect lower division undergraduate fees. Upper division undergraduate fees are: in-state instructional fee, \$1,562; general/facilities fee, \$44; and out-of-state surcharge, \$440.

3a. Amounts reflect lower division undergraduate fees. Upper division undergraduate fees are: in-state instructional fee, \$1,656; general/facilities fee, \$44; and out-of-state surcharge, \$1,583.

4. Effective Fall 2005, Summit College students entering baccalaureate programs are charged the UA main campus rate.

4a. Effective Fall 2008, the University of Akron redesigned a non-mandatory parking fee into a transportation fee that is charged to all full-time students. Since the transportation fee is paid by all full-time students, it appears in the Regent's annual survey as a general fee. The transportation fee, however, is not uniformly assessed to all students and therefore not subject to the legislative mandate restricting (instructional and general) fee increases at Ohio's public colleges and universities.

1. The out-of-state surcharge for doctoral students attending Cleveland State University is \$2,187.90 per semester, which represents 40% of the maximum out-of-state surcharge of \$5,469.10 per semester.

2. Beginning with Fall 2010, Miami University graduate students pay a comprehensive tuition/fee which includes both the instructional and general components. This fee is reported in the instruction fee category above.

3. The Instructional Fees and Out-of-State Surcharge reflect amounts assessed to students enrolled after summer 2009. Instructional Fees and Out-of-State Surcharge for students enrolled prior to Fall 2009 are \$6,745 and \$4,528 respectively.

1. Rio Grande Community College does not accept out-of-state students. Out-of-state students may be admitted to the University of Rio Grande, a private institution with which the community college is affiliated. In addition, please note that Rio Grande charges a technology fee to all full-time students registered for 6 or more credit hours per term. Since the technology fee is paid by all full-time students, it appears in the Regent's annual survey as a general fee. The fee, however, is not uniformly assessed to all students and therefore not subject to the legislative mandate restricting (instructional and general) fee increases at Ohio's public colleges and universities.

2. Sinclair Community College approved a mid-year fee increase Winter Term 2011. Effective January 2011, the in-district instructional fee = \$671 per term; general fee = \$98 per term; out-of-district = \$473 per term and the out-of-state surcharge = \$1,635.

1. Columbus State approved a fee increase in FY 2010, that ***will be waived***. Effective Winter 2010, the in-state, undergraduate instructional fees for a full-time student will be \$1,091.25 per term and the out-of-state surcharge fee will be \$1,488.75 per term.

2. Northwest State currently has approval from the Chancellor to waive \$75 per term in tuition and fees such that the effective annualized tuition rate for in-state undergraduate students is \$3990. Note, however, that the actual annualized tuition rate is \$4,140.

3. Rio Grande Community College does not accept out-of-state students. Out-of-state students may be admitted to the University of Rio Grande, a private institution with which the community college is affiliated.

4. Sinclair Community College approved a mid-year fee increase Winter Term 2011. Effective January 2011, the in-district instructional fee = \$671 per term; general fee = \$98 per term; out-of-district = \$473 per term and the out-of-state surcharge = \$1,635.
